Subject: Approval of the proceedings and list of eligible and excluded applicants – Call for applications for the allocation of the ministerial contribution for housing rental expenses incurred by non-resident students for the year 2025, pursuant to Article 1, paragraphs 526 and 527 of Law no. 178 dated 30 December 2020, Article 1, paragraph 580 of Law no. 197 dated 29 December 2022, and Ministerial Decree no. 630/2025 – Financial Year 2025

THE RECTOR

HAVING REGARD TO Rector's Decree no. 645 dated 17 October 2016, by which the University Statute was issued;

HAVING REGARD TO the Prime Minister's Decree (D.P.C.M.) of 9 April 2001, containing "Provisions for the uniform treatment of the right to university education pursuant to Article 4 of Law no. 390 dated 2 December 1991", and in particular Article 4, paragraph 8, point 3, which defines a "*non-resident student, residing far from the location of the course attended, and who for this reason takes paid accommodation near that location, using public residential facilities or other private or institutional accommodation for a period of no less than ten months. If a student living far from the location of the course takes free accommodation near that location, he or she is considered a commuter student*";

HAVING REGARD TO Legislative Decree no. 68 dated 29 March 2012, revising the general principles governing the right to education;

HAVING REGARD TO Law no. 178 dated 30 December 2020, and in particular Article 1, paragraphs 526 and 527, which provide as follows: paragraph 526: "*In order to support non-resident students enrolled in state universities, belonging to a household with an Equivalent Economic Situation Indicator (ISEE) not exceeding 20,000 euros and not benefiting from other public housing contributions, a fund is established within the budget of the Ministry of University and Research with an allocation of 15 million euros for the year 2021, aimed at providing a contribution for housing rental expenses incurred by such non-resident students residing in a location different from that of the rented property.*"; paragraph 527: "*By decree of the Minister of University and Research, in agreement with the Minister of Economy and Finance, to be issued within sixty days from the entry into force of this law, the procedures and criteria for the allocation of the fund referred to in paragraph 526 shall be defined, also to ensure compliance with the maximum expenditure limit, through the universities, providing for the non-cumulation with other forms of support for the right to education related to housing*";

HAVING REGARD TO Law no. 197 dated 29 December 2022, and in particular Art. 1, paragraph 580, which provides that "*The fund referred to in Art. 1, par. 526, of Law no. 178 dated 30 December 2020, is refinanced with 4 million euros for the year 2023 and 6 million euros annually starting from 2024*";

HAVING REGARD TO Law no. 207 dated 30 December 2024, and in particular: Art. 1, par. 120, which increases the fund referred to in Art. 1, par. 526, of Law no. 178 dated 30 December 2020, by 1 million euros for the year 2025 and by 2 million euros for each of the years 2026 and 2027; and Art. 1, par. 870, which, for the purpose of contributing to the achievement of the public finance objectives of the Medium-Term Structural Budget Plan 2025–2029, provides for a reduction of 300,000 euros in the allocation of the aforementioned fund starting from 2025;

HAVING REGARD TO Decree-Law no. 45 dated 7 April 2025, converted with amendments by Law no. 79 dated 5 June 2025, and in particular Art. 6, par. 1-ter, which states: "*The fund referred to in Article 1, paragraph 526, of Law no. 178 dated 30 December 2020, is increased by 9.5 million euros for the year 2025. The related expenditure, amounting to 9.5 million euros for the year 2025, shall be covered by a corresponding reduction in the allocation of the current expenditure special fund included, for the purposes of the 2025–2027 three-year budget, in the 'Reserve and Special Funds' program of the 'Funds to be Allocated' mission of the budget forecast of the Ministry of Economy and Finance for*

the year 2025, partially using the reserve related to the Ministry of University and Research”;

HAVING REGARD TO Ministerial Decree no. 630/2025, which sets out provisions regarding *Contribution for housing rental expenses incurred by non-resident students*, pursuant to Art. 1, paragraphs 526 and 527, of Law no. 178 dated 30 December 2020, as amended by Law no. 79 dated 5 June 2025 converting Decree-Law no. 45 dated 7 April 2025, and which, among other things, defines the procedures for the allocation of funding, the issuance of related calls for applications by universities, and the eligibility criteria for students applying for the benefit;

HAVING REGARD TO Note no. 17885/2025 from the Ministry of University and Research (MUR), which informed universities of the initiative for the year 2025, requesting the issuance of the relevant calls and the submission of final data on eligible students through a dedicated online platform;

HAVING REGARD TO Rector’s Decree no. 808 dated 24 October 2025, by which the call for applications was issued for the allocation of the ministerial contributions for housing rental expenses incurred by non-resident students for the year 2025, pursuant to Article 1, paragraphs 526 and 527, of Law no. 178 dated 30 December 2020, Article 1, paragraph 580, of Law no. 197 dated 29 December 2022, and Ministerial Decree no. 630/2025 – financial year 2025;

HAVING REGARD TO Rector’s Decree no. 840 dated 31 October 2025, by which the Evaluation Committee was appointed for the allocation of the contribution referred to in Rector’s Decree no. 808 dated 24 October 2025;

HAVING REGARD TO the minutes of the Committee appointed by the aforementioned Rector’s Decree no. 840 dated 31 October 2025, together with the attached list of eligible and excluded applicants;

VERIFIED the regularity of the documents and procedures carried out by the aforementioned Committee

HEREBY DECREES

1. The proceedings of the Evaluation Committee appointed by Rector’s Decree no. 840 dated 31 October 2025, concerning the allocation of the ministerial contribution for housing rental expenses incurred by non-resident students for the year 2025, pursuant to Art. 1, paragraphs 526 and 527 of Law no. 178 dated 30 December 2020, Art. 1, paragraph 580 of Law no. 197 dated 29 December 2022, and Ministerial Decree no. 630/2025 – financial year 2025, as referred to in Rector’s Decree no. 808 dated 24 October 2025, are hereby approved;
