**To this end, making use of the provisions set out in the Articles 3 and 47 of Presidential Decree 445/2000 and aware, pursuant to Article 76, that anyone who makes false statements, creates false documents or uses them, is punished pursuant to the Criminal Code and specific laws on the matter and also incurs the forfeiture of the benefits referred to in Article 75,**

DECLARES UNDER HIS OWN RESPONSIBILITY TO BE IN POSSESSION OF THE FOLLOWING REQUIREMENTS:

- To be enrolled in the 2024/2025 academic year in a first or second level degree course at the Luigi Vanvitelli University of Campania, up to date with the payment of university fees and contributions for the same year, with an ISEE in the University database (ESSE3) no higher than € 20,000.00;
- To meet the merit requirements set out in Article 1, paragraph 255, letters b) and c) of Law 232/2016, or to fall within the categories of students exempt from the merit requirements as indicated in the competition announcement;

<sup>1</sup>The aforementioned declaration can be issued by European Union citizens. It can also be issued by citizens of non-EU countries legally residing in Italy, provided that the data declared can be certified or attested by Italian public bodies (Article 3, paragraph 2, Presidential Decree no. 445/2000). Declarations in lieu of a sworn statement cannot contain expressions of intent (acceptances, waivers, delegations, assignments, commitments, or other contractual acts).

- To be a non-resident student who therefore resides in a municipality other than that where the course of study attended is based, with a minimum distance between the two municipalities of at least 30 km, as indicated below:
